Region 5 Report - Randall Beasley

My bow broke!!

One week before a Colorado elk hunt, my favorite 1988 (era) Bear takedown bow riser broke. I was at full draw one instant, and in the next, the bow was in two pieces on the ground. For a day or two I was in shock and really did not know how to feel or what to do about this bow breaking. But I had a decision to make. Should I cancel the trip? I decided a backup bow was necessary regardless whether I made the trip to Colorado. Unfortunately, I only had three takedown left-hand risers: the broken one, a Satin model purchased new in 1998, and a magnesium riser from 1971. The only other left-handed bows in my collection were for kid's. While the 1998 bow was ready to go, the metal riser was not set up properly with the correct limbs, string, or quiver. The quiver being the most important item. The metal riser needed a bow-quiver. With a little work and some luck, I was able to fit my newer style quiver on the old metal riser. Now, I had a backup bow. Everyone knows you must take two bows on any hunting trip if space and weight limits allow.



Now why did my favorite bow break? I may never know the answer, but I have some thoughts. Since, the bow was not purchased new, it may have been abused by the previous owner. However, over the years of shooting the bow, a few bowstrings have broken, some arrow knocks have broken, and some arrows have slipped off the string. As you know, all these result in a dry fire, which can harm bow limbs, bows-bow risers, or bow shooters. This could be a reason the bow riser broke. It might have been that I kept the bow strung 24/7 for years, only unstringing it to change bow limbs, replace bowstrings, or wax bowstrings. Currently, Illinois law requires either unstringing, locking the string or bow, or casing the bow when transporting in a vehicle. While I use a bow case, I was almost always careful not to leave any bow inside a hot car. Well almost never. Perhaps, this may have been the reason the bow broke. What about the adhesive bow saddle I installed on the bow? Did that adhesive effect the wood in the bow and cause it to break? Another cause could relate to the way the bow was made. Was its wood properly treated when converting it to what Bear Archery calls "Future wood"?



After considering these possible reasons, I returned to my initial thought, which was the design of the arrow shelf. Since Fred Bear shot off his knuckle, he cut the shelf down very low so the arrow would rest on his hand instead of the bow. In one of his books, he commented that he could not shoot a bow wearing gloves partially because a glove causes the arrow to rise higher than normal and effect the arrow flight and shot placement. This bow had an arrow shelf cut very low. The arrow rested just above my hand, no more than one-fourth of an inch. I think that all of these are factors in this bow coming apart. I cannot change previous actions, but maybe with my next bow I can do better. My next favorite bow will be the 2020 50th anniversary B-riser in Black Maple which is currently on backorder. I am hopeful that this new Fred Bear takedown will last at least 30 years too.

We are tentatively planning for April 17 for this event. We will have more information at the banquet March 6th.

Ready for season

With this covid thing I've been having more time to prepare for this season. Food plots are in and trail cams are letting me know the health and numbers of my local deer. As there is nothing exceptional showing up this year on the cams I may choose to hunt other locations more. I am concerned about the odd shapes of many of the racks I'm seeing. Ordinarily most bucks in my area are very symmetrical 8 pts but this year has produced a lot of deformities. Arrow tuning has been very interesting. I have a 48# Blacktail that I've had a great deal of trouble getting good arrow flight with. I had mentioned it to someone at Blacktail and they said the bows are designed to shoot a very heavy arrow. After trying several different spined sets of wood arrow I picked out a set of 75-80 spine weight arrows with 190 grain heads and what do you know. They hit where I expected them to. Also they weighed in at over 600 grains. The most interesting thing about these arrows is that I had made and sold them to John Krohn years ago and had just recently purchased them back from his wife Mary. John passed away this spring. I am hoping to take a deer with them this season in John's memory.

Be safe, hunt hard, shoot straight.....



Region 3 Report - Ron Hayford

We are still on for the Region 3 Rendezvous this fall at Wolf Creek State Park at Lake Shelbyville on October 15, 16, 17, 18 of 2020. Due to the Covid thing, we will not have the potluck on Saturday night. We will instead have a catered meal served safely with proper social distancing in effect. We may have to sit a little farther apart around the campfire, but really not much else will change. If you are looking for a place to go this fall, come spend the weekend at Wolf Creek state Park. You will not need a camping reservation. The park superintendent has set aside a large number of campsites for us on a first come basis. You just pay when you have picked a spot.

We are trying to help the family of fellow UBI member John Krohn. His wife Mary is at a loss as to what to do with a lifetime of archery related items. We will have many of the things for sale at the rendezvous. I hope you will consider chipping in and buying something of his. I plan to hunt this fall with a quiver and a set of his arrows as a tribute to his dedication to archery and the UBI. The items I have include equipment, bows, arrows, and books. I will include a partial list. Equipment includes: arrow spine tester, continuous loop string making jig, aluminum arrow straightener, Bitzenburg fletching jigs with right and left wing clamps, little chopper 5 inch shield right wing, tape on bow fishing reel and fiberglass fishing arrow. The left-handed bows are Jeffery 60 inch 35 #, Bear Super Grizzley 58 inch 45#, and Howatt Balboa 58 inch 45#. The right-handed bows are a York Crescent 64 inch 28#, Jeffery 66 inch 33#, Wing Thunderbird 54 inch 55#, Shakespeare Necedah 58 inch 54#, and a Pearson Hunter II 7085 58 inch 45/50#. We also have some youth fiberglass bows. Arrows- some bare shafts by the dozen which are mostly heavy ie. 90-100#. If you know someone looking for some good heavy cedar wooden shafts let them know about these. We also have several sets of six fletch Flu Flu arrows, a six arrow set in a bow quiver with Ace broadheads, and many more odd lots of 3, 4, 5, or 6 arrow sets. Come look them over. Finally, we have about 40 books. I will list some but not all of the titles- Archery Tackle by Adolph Shane, Whitetail Tactics with Recurves and Longbows by Jim Hamm, Buckskin and Bone (Post Graduate Whitetails) signed by Gene Wensel, The Traditional Way by Fred Anderson, Instinctive Shooting II by G. Kroeber. There is more, it will be for sale or donation at the rendezvous.

UBI Crossbow Position Statement

The United Bowhunters of Illinois is adamantly opposed to the inclusion of any weapon that is not hand drawn and hand held in Illinois' archery season. Specifically, we are opposed to the use of the crossbow and the drawlock device, as well as any other weapon that does not require the shooter to draw by hand, hold by hand, and release by hand. Such weapons have the potential to negatively alter the primitive weapon status originally designated for archery seasons in Illinois

We are not opposed to the use of such devices by the truly handicapped, but we do question the legitimacy of some of these cases. Therefore we support all efforts by the IDNR to maintain the integrity in issuing handicap permits so as to minimize abuse in this practice

UBI Archery Season Position Statement

The United Bowhunters of Illinois is opposed to the creation of any new hunting season, or the extension of any existing hunting season which will decrease the length of the archery only season or displace the season into less favorable dates. While the United Bowhunters of Illinois recognizes the rights of hunters who choose to use other weapons in separate hunting seasons, we will oppose all efforts to include such users in Illinois' archery season

UBI Big Game Shooting Enclosure Position Statement

The United Bowhunters of Illinois opposes any big game hunting where the animal is within the confines of game proof enclosures. We oppose this despicable practice on the grounds of fair chase hunting, the threat of disease spreading from captive cervids to our wild deer populations, and the fact that privatizing wildlife is contrary to the North American model of game management. It is our position that the selling of hunts for big game animals that have been raised within an enclosure, or animals that currently are confined within an enclosure should be illegal in Illinois
